The mission of The Children's Assessment Center (The CAC) is to provide a professional, compassionate and coordinated approach to the treatment of sexually abused children and their families and to serve as an advocate for all children in our community.

*In this Annual Report, we offer a comprehensive overview of The CAC's activities during the past fiscal year (from October 1, 2022, to September 30, 2023) and highlight the results achieved. Our progress would not have been possible without our dedicated staff, MDT partners, civic leaders, donors, and volunteers, who actively participate in our shared responsibility to safeguard children.

A Message from The CAC Executive Director

Dear Friends and Supporters,

As the sole advocacy center in Harris County serving sexually abused children and their families, The CAC remains committed to excellence. In 2023, the organization experienced tremendous growth and introduced exciting new initiatives.

We are living in a time when the world has taken notice of the need for quality, affordable mental health services. I am proud to share that in 2023, The CAC provided over 10,000 mental health services to children,



siblings, and non-offending caregivers, all free of charge. We know that children who enter adulthood with unresolved trauma are more likely to experience negative outcomes such as drug addiction, mental health issues, unwanted pregnancy, poor health, and interactions with the criminal justice system. Our children deserve better, and our mental health services give them the tools they need to manage trauma and lead happy, productive lives.

In 2023, the Harris County Commissioner's Court provided us with the resources necessary to adopt Children's Court Services, an entity that has existed for 40 years, providing support to children as they prepare to testify in court. As you can imagine, facing your abuser can be a terrifying experience. These caring professionals are available in court to provide emotional support. The value their support has to our children and families is immeasurable, and we are grateful to have them on our staff.

Looking forward, we envision a world free of child sexual abuse. Simply put, we want to put ourselves out of a job. We strongly believe, and research shows, that the way to do this is through prevention training for both children and adults. One of our greatest accomplishments of 2023 was a significant increase in our Training and Education Department. With the support of Harris County and a generous grant, we were able to double our training staff, allowing us to provide training to almost 38,000 people in our community, including 25,000 children.

Thank you for your continued support and dedication to our mission.



By offering a safe haven and leadership in the child advocacy movement, The CAC not only aids in the healing process but also works towards preventing future abuse and raising awareness about these critical issues. 

With nearly 40,000 reports of child abuse received annually in Harris County and almost 3,400 children sharing their disclosures of abuse at The CAC, the center's role in the community is both significant and impactful. By offering these services in one central location, The CAC ensures that children and families have access to coordinated care tailored to their unique needs, fostering a path towards healing and recovery.

What We Accomplished Together



These statistics are a testament to the critical role The CAC plays in providing services to children affected by various forms of trauma. The data also highlights the importance of tailored services to meet the needs of different age groups and the prevalence of abuse by individuals known to the victims.

The Children's Assessment Center has achieved remarkable milestones in FY2023 across its six core specialized services.

Joint Investigation Coordination

A total of **38,136 DFPS reports of abuse and neglect were** reviewed. This includes **10,799 reports related to child sexual abuse and child sex trafficking.**

Forensic Interviews

3,375 children underwent forensic interviews, a critical step in the investigative process.

Family Advocacy and Victims Support

2,537 families benefited from 5,281 family advocacy services, providing essential support during challenging times.

Trauma-Focused Mental Health

10,500 mental health services were provided, which reached 893 children and 254 adults.

Medical Evaluations

1,039 children received medical evaluations, ensuring

health and wellbeing following abuse allegations.

MDT Case Review

The Multidisciplinary Team (MDT) formally **reviewed 306 cases**, facilitated by The CAC, to ensure comprehensive care and support.

What We Do

The core programs of The CAC are meticulously designed to foster a collaborative environment that reduces trauma, interrupts the cycle of abuse, and equips families with the tools to safeguard their children. The CAC delivers a range of services tailored to address the comprehensive physical and psychological needs of children who have experienced sexual abuse, as well as their siblings and non-offending caregivers. These core services are accessible through specialized divisions, including Multidisciplinary Team Services, Forensic Services, Family Advocacy and Victim Support, Medical Evaluations, and Therapy and Psychological Services. Additionally, The CAC extends further support services like Children's Services, Children's Court Services, Community Outreach, Education and Prevention, and Child Sex Trafficking initiatives, all aimed at bolstering the provision of services to children and families affected by child sexual abuse.

Multidisciplinary Enhancement Initiative

The CAC's Multidisciplinary Enhancement Initiative (MEI) has been pivotal in enhancing the collaboration among law enforcement and the Texas Department of Family and Protective Services. This initiative has been instrumental in:

Strengthening the Multidisciplinary Team: Ensuring all children have timely access to the complete range of services offered by The CAC.

Improving Communication: Facilitating effective communication, coordination, and collaboration at every stage of service delivery.

Promoting Safety, Justice, and Healing: Aiming to provide child sexual abuse survivors and their families with the necessary support for recovery.

The integration of child abuse reports from the child abuse hotline directly into the new case management system in 2023 marks a significant improvement in the efficiency of The CAC's operations. This advancement ensures that:

- The CAC receives this critical information promptly.
- The assessment of cases fitting CAC service criteria is more efficient.
- There is a reduction in manual data entry, **saving time** for staff.
- CAC staff can dedicate more time to serving children and families.

Multidisciplinary Team Partners

The Harris County Multidisciplinary Team (MDT) plays a crucial role in addressing child abuse and exploitation.

MDT Approach. The MDT approach involves professionals from various fields working together to support child victims of sexual abuse and child sex trafficking. These professionals collaborate with The CAC staff to ensure an effective and coordinated response. Their goal is to minimize trauma for children and families while respecting the rights and responsibilities of each agency involved.

Interagency Collaboration. The MDT fosters collaboration among law enforcement, medical and mental health professionals, nonprofits, and governmental investigative entities. By working together, the MDT enhances the quality of care provided to child victims. This collaboration is essential for a comprehensive and compassionate response.

Mission. The Harris County MDT's mission is to provide the best possible response for every child victim. Insight from each MDT representative contributes to an environment that fulfills this mission.

Forensic Services

The CAC provides children a safe place to tell what, if anything, happened to them in a neutral setting to experts who listen to them and help them heal. The goal of Forensic Services is to:

Minimize trauma to children by reducing the number of times a child is interviewed during an investigation of child abuse.

Obtain a child's statement in an objective, developmentally sensitive, and legally defensible manner.

Conduct the highest quality interviews and assessments using forensically sound methods and techniques.

Provide support to the non-offending caregivers during the investigative process.

Assess levels of trauma to children to ensure meaningful and appropriate clinical referrals for ongoing services.

3,375 Forensic Interviews 106 Extended Forensic Interview and Evaluation Sessions 402 Clinical Assessments

The CAC's Clinical Assessment program received 756 referrals. 396 assessments were completed, and 301 referrals were submitted for trauma-informed therapy services. Clinicians also completed 58 Child and Family Traumatic Stress Intervention sessions.

Victim Support and Advocacy

Family Advocates at The CAC provide victim support and advocacy services to all clients and their caregivers as part of the multidisciplinary team response. The focus of advocacy is to reduce trauma to children and families, improve outcomes, and facilitate access to comprehensive support services. Our team of master's level social workers are available to assist families in crisis and support and encourage participation in comprehensive services.

Most notably, Family Advocacy saw an increase of 6% in client services, while follow-up advocacy services increased 19%.

Medical Evaluation

Baylor College of Medicine and Texas Children's Hospital play a crucial role for the community by providing exceptional care at The CAC to children impacted by child sexual abuse. Under the direction of Dr. Reena Isaac, MD, children are treated by highly qualified physicians and certified advanced practice providers (APPs) who are specially trained to handle sensitive cases.

The medical team conducts specialized evaluations in a setting that is designed to be child-friendly and nonintimidating, significantly reducing the discomfort and fear a child might feel during such procedures. These medical exams are crucial for any child with allegations or concerns of abuse, as they serve multiple purposes:

Assessing the child's overall well-being, health, and safety.

Collecting evidence and documenting any signs of trauma.

Screening for sexually transmitted infections, injuries, and pregnancy.

Above all, the medical evaluation seeks to provide reassurance to both the child and their family, affirming the child's physical well-being. 2023 statistics underscore the program's unwavering commitment and its profound impact on the lives of vulnerable children.

Children's Services

The primary goal of the Children's Services Division is to support the services provided by The CAC by providing children a safe, nurturing place to play and interact with peers before and after services. The Children's Services Division includes the Activity Center, a volunteer and intern program, the Rainbow Room, art activities, holiday gift and clothing drives, and an annual back-to-school program. Additionally, Children's Services hosts the annual children's holiday party, back-to-school event, and many other childfriendly fun activities throughout the year. The CAC's onsite Activity Center, which is staffed by four CAC staff members and specially trained volunteers and interns, provides a safe haven for children while awaiting services or during a lengthy investigation of alleged abuse.

Trauma Informed Therapy


The Therapy and Psychological Services Division at The CAC provides evidence-based, trauma-informed mental health services to children, siblings and caregivers impacted by child sexual abuse. Specialized treatment is instrumental in caring for the emotional well-being of survivors and includes the following services: crisis intervention, psychological evaluation, psychiatric care, and individual, group, and family therapy. Upon referral, every child is evaluated so that a unique treatment plan may be developed for each child, sibling, and non-offending caregiver. Services are offered in both English and Spanish and at multiple locations including The CAC, telehealth, and in outlying communities.

100% of caregivers surveyed were very satisfied with the mental health services their child received. Caregiver feedback included:

Education and Prevention

The CAC provides professional development and continuing education opportunities for professionals who work with children, health care, school personnel, parents, children and community members who want to learn more about child safety and protection. The goal is to raise community awareness by providing informative and evidence-based trainings and quality prevention programing to address child sexual abuse. Emphasis is placed on identifying signs and symptoms of sexual abuse, Texas reporting laws, trauma-informed care, and preventing all forms of child maltreatment. Trainings are offered virtually, live, and hybrid.

> Training opportunities included: Monique Burr Foundation - Child Safety Matters and Teen Safety Matters, Darkness to Light - Stewards of Children, Netsmartz, P.S. It's My Body, Volunteer Training, and MDT Orientation, in addition to a host of professional education opportunities for The CAC staff and partner agencies.

In 2023, The CAC collaborated with Spring Independent School District to provide prevention training to Elementary and Middle School students.

796 trainings were provided to 18,693 Elementary School students. 94 trainings were provided to 2,466 Middle School students.

Caregivers' Point of View

In 2023, 330 caregivers receiving initial and follow-up services at The CAC responded to our survey. The CAC uses the Outcome Measurement System (OMS) to demonstrate the value of the work The CAC provides to children and families and the success of the CAC model in the eyes of the MDT.

Key Statistics The feedback from caregivers about The CAC is overwhelmingly positive, which speaks volumes about the quality of care and support provided.

Feeling of Safety: 92% of caregivers agreed their child felt safe at The CAC.

Timely Attention: 96% were satisfied with the timeliness of the greeting and attention received.

Friendly Staff: 95% strongly agreed that the staff members at The CAC were friendly and pleasant.

Informed Caregivers: 93% agreed they knew what to expect after their visit at The CAC.

CAC Employee Wellness Program

The CAC Wellness Ambassadors actively enhance employee well-being through initiatives that promote health, happiness, and a compassionate organizational culture. 2023 events included Bingo on the Rooftop, quarterly Wellness Carts, and Wellness Wednesdays. Additionally, two affinity groups were launched including a running club and a book club. These events fostered camaraderie and provided moments of relief for clinicians and staff. These initiatives reinforced their value and reminded staff that they are not alone.

Reminding everyone of the talented, kind-hearted individuals they work with.

CAC Cultural Competency Committee

With the goal of fostering a vibrant and dynamic organizational culture, The CAC Cultural Competency Committee regularly shares information with their departments to raise awareness. They offer the following trainings for CAC staff members:

Diversity, Equity & Inclusion Training: This session focuses on understanding the role of cultural competency in both the workplace and clinical settings.

Cultural Competency When Working With the African American Community: A specialized training to enhance cultural competence when interacting with the African American community.

Training Center Information Monitor: The Training Center displays cultural competency information for staff, partner agency staff, and community visitors.



Child Sex Trafficking Initiatives

The CAC takes the lead in Harris County's response to child sex trafficking (CST), co-facilitating the Child Sex Trafficking Advisory Council alongside Harris County Resources for Children and Adults. This council coordinates a county-wide network of agencies charged with guiding affected children towards safety, justice and healing through a trauma-informed approach.

The CST multidisciplinary team held 160 trafficking related Rapid Response Team calls and reviewed 67 trafficking cases in 2023.

Furthermore, The CAC extends its full array of services to the CST MDT, including case coordination, care review, forensic interviews, advocacy, medical evaluations, and mental health services for both trafficked youth and their caregivers. Additionally, The CAC provides essential items like hygiene products and clothing to youth upon recovery, prioritizing these referrals. Collaborating with other community organizations, The CAC also offers transportation vouchers and necessary resources to support trafficked youth post-recovery.



In 2023, The CAC took significant steps to combat child sex trafficking in Harris County:

Led revisions to the Child Sex Trafficking Team Care Coordination Protocols, ensuring alignment among agencies on procedures for trafficked children.

Hosted various in-person and virtual trainings on trauma-informed practices and trafficking awareness.

Hosted trafficking related workshops, a press conference, and media interviews during Human Trafficking Awareness month.

Acted as co-care coordinator for all child sex trafficking cases in Harris County.

Engaged in media interviews, attended trafficking conferences, and conducted presentations on child sex trafficking.

Generosity in Action

President's Letter

Dear Friends of The CAC,

In the 1990s, I served as an Assistant District Attorney in Harris County, Texas. In that role, I handled many cases involving the sexual abuse of children and tried quite a few of those cases in front of juries. From that experience, I witnessed first-hand how difficult it is for children to navigate the criminal justice system. Thankfully, those child victims in Harris County are served by The Children's Assessment Center.



The aim of The Children's Assessment Center is to provide services to avoid re-traumatizing children who have

been the victims of abuse. The Children's Assessment Center provides forensic interviews, medical services, and ongoing therapy and support services free of charge so that a child's journey through the criminal justice system is as painless as possible. Those support services are also offered to families so that both the child and his or her caregivers have the opportunity to heal.

The Children's Assessment Center also seeks to prevent the abuse of children by providing training in the community to children, families, schools and other organizations. The goal of the training staff is to see a day where no child has to walk through its doors to receive services as a result of being abused.

I am humbled to now serve on the Board of Directors of The Children's Assessment Center Foundation. Our purpose is to raise funds for and advocate on behalf of The Children's Assessment Center. I am thankful for the opportunity to give back to an organization that was so instrumental in helping me advocate on behalf of abused children and that has supported thousands of other children over the years. I hope The Children's Assessment Center can count on your ongoing support so that it may continue to provide critically needed services to child victims of abuse and expand its education efforts to prevent other children from becoming victims.
